The Government of Ukraine *has received* financing from the World Bank toward the cost of the *Strengthening Public Resource Management Project (hereinafter - Project)*, and intends to apply part of the proceeds toward payments under the contract for Implementation of Human Resources and Payroll Management Information System within *the Part A of the Project: Strengthening Human Resource Management in Public Administration Institutions*.
2. National Civil Service Agency of Ukraine now invites sealed Bids from eligible Bidders for *Supply and Installation of Human Resource Management and Payroll Information System*.
3. Bidding will be conducted through international competitive procurement using Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" dated *July 1st, 2016 and revised November, 1st 2017* ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.

5. The bidding document in English and Ukrainian languages may be collected by Bidder's authorized representative at the address below or sent via e-mail to the interested eligible Bidder upon the submission of a written application in hard copy or electronic form to the address indicated below.
6. Bids must be delivered to the address below on or before *11:00 September 19th 2018*. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on *11:00 September 19th 2018*.
7. All Bids must be accompanied by a Bid Security of one hundred thousand (100 000) US Dollars or an equivalent amount in the currency of the Bid at the National Bank of Ukraine exchange rate (www.bank.gov.ua).
8. Implementation of *Supply and Installation of Human Resource Management and Payroll Information System* is divided in two phases. The Bidder has to provide the Bid for both phases. It is envisaged that the Contract will be concluded for the implementation of Phase 1 only. Implementation of Phase 2 will be enabled by the Amendment to the Contract signed subject to the funds availability and satisfactory performance of the Supplier.
